



**GRRB Youth Work Experience Program Application Form**

The Youth Work Experience Program was established by the GRRB in 2000 to provide youth with hands on experience in the renewable resources field. When GRRB projects are undertaken near a community, youth from that community may be hired on a short-term basis to assist staff in the field. Activities will be supervised by a responsible adult and may include collecting samples in the field, assisting with recording data, assisting with the delivery of education programs, heavy lifting, working with equipment and travel by vehicle or boat. The GRRB has a safety policy that will be followed and youth will be provided an orientation to the activities as well as to safety procedures. The length of work experience will vary with the projects and range from a half day to several days. Youth will be paid at the NWT hourly minimum wage rates of \$12.50/hr with a minimum of 4 hours per day paid and overtime at 1.5 for any hours over 8 hours, according to NWT employment standards.

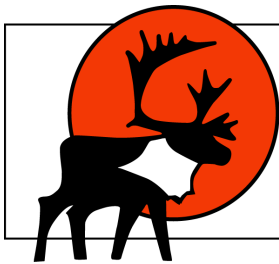
