4. Review of outstanding action items

Amy Amos, Executive Director, provided an update on outstanding action items, including those arising since the last Board meeting. The list of action items is available in the meeting binder.

5. Review of GRRB Reports

5a. Chair Report

The Chair, Josef Carnogursky provided a brief overview of his report. Report available in the binder. He has been in the office to help with GRRB administration with Amy, Cheryl, and Mary Ann.

5b. Members

Board Member updates are available in the binder.

5c. Executive Director Report

The Executive Director, Amy Amos opened her report by speaking in Dinjii Zhuh Ginjik (native language) to introduce herself and her family. She has been with the GRRB for 15 years, and as the Executive Director for 12 yrs. Her report is available in the binder. To note is that Édouard Bélanger, Wildlife Biologist, is leaving the GRRB in April 2021 and Laurence Carter, Management Plan Coordinator is leaving her one year term early in March 2021. The Chair thanks Édouard and Laurence and wishes them both all the best and thanks them for all the work and time with GRRB.

5d. Staff Reports

Written reports by staff are provided in the binder as information only.

6. Agency Reports

6a. Government of the NWT, Department of Environment and Natural Resources

Norman Snowshoe, Ernie Francis, Rolland Malegana, Marsha Branigan

The written update is provided in the binder. Norman provided an update on staff and staff acting in other capacities within his department and turns other reporting over to ENR staff in attendance.

Ernie Francis, Acting Manager of Field Operations provides a verbal report. Officers work with the public by appointment only due to Covid19. Patrols were increased in Aklavik to monitor the caribou harvesting. There was a rabies outbreak in Tuktoyaktuk; Officers are handling and monitoring the situation. A rabies vaccination clinic was carried out in late January. Some education programs are taking place in schools on snaring and trapping.

Roland Malegana, Forests Manager provides a verbal report on the upcoming 2021 Fire Operations Season and timber permits. ENR is preparing to update the Gwich'in Forest Management Plan with GRRB and GTC. A working group has been formed with a term of reference signed by GRRB, GTC, and Superintendents of the Beaufort region.

Marsha Branigan, Wildlife Management Manager provides a verbal report on the Research Monitoring programs that are underway, ENR continues to be apart of the working group on the Action Plans of the Bluenose east and Bluenose west, Cape Bathurst Herds. Preparations are underway for the 2021 Barren Ground Caribou surveys. The plan is to conduct a fixed wing survey in March and a more systematic recon than usual so that they can do a Muskox abundance as well as the caribou distribution. Additional information was provided on harvest monitoring samples collected on wolves and wolverines. There will be more discussions on Grizzly bears and landfills soon. The last photo survey was done in 2017 and will do a planned survey this summer.

6b. Department of Fisheries and Oceans Canada (DFO)

Herb Nakamayak, Kevin Bill, Ellen Lea - DFO

Herb Nakamayak provided a broad verbal update. Since June 1st, GRRB met with DFO and Coast Guard a few times. Grand Chief Ken Smith has had discussions with the Assistant Commissioner with the Coast Guard on employment opportunities, education and expanding DFO and Coast Guard's outreach. They ensure they are respecting the traditional Indigenous Knowledge holders in respecting their rights and traditional knowledge of those they work with and those over the years. There is a document on the Kay family at the Rat River and how they started with the Char management program and how successful that is, as a model.

Kevin Bill provides a verbal report. The official implementation of the Arctic Region happened on June 1st, 2020. He is currently acting Regional Director of Arctic Operations for the Arctic Region. Allison McPhee is the acting Regional Director of the Fisheries Management Program. Debbie Ming is on assignment as Regional Director of Marine Conservation and Planning, formerly Oceans. DFO is working on staffing these executive positions and several other positions in the new Arctic Region. Community Engagement Coordinators are Leah Ipana in the Inuvik Office and Laverna Klingenberg in the Ulukhaktok office. The Arctic Region is finalizing their Traditional Knowledge framework and will reach out to the GRRB and other co-management boards once it is ready for their review. There is a new Traditional Knowledge Coordinator position to be filled soon and there is a Manager for Arctic Employment in Rankin Inlet in place to work with Indigenous Recruitment and Retention Strategy. There is the possibility of a Science Director position for the Arctic Region. The boundary for the Arctic Region will be announced soon and DFO will share this information with the Board. The DFO offices in the Arctic Region are open but at 50% capacity, with 3 or 4 people in the Inuvik office at any one time. Travel is to follow CPHO guidelines and only for occurrences and following up on investigations.

The Board followed up with questions on DFO's presence in the Gwich'in Settlement Area (GSA). With respect to programs, DFO has added staff in Hay River providing services for Fisheries Management. There are now two C&P Officers in Hay River. For Conservation and Protection (C&P), Gerald Fillatre is Senior Manager in Yellowknife and responsible for managing all C&P staff and sends his regrets. Christian Marcoux also sends regrets. The Regional Director of C&P has indicated there is a process for hiring new officers this year. It is an ongoing comment from the Board and other co-management boards and agencies to have more presence in their respective areas. DFO will be looking to address this in the future, but no specific plans for Officers in Inuvik at this time. Kevin will bring that back to upper management as information from the Board.

7. Species at Risk

7a. Northern Mountain Caribou listing as special concern (NWT SAR)

Kaytlin Cooper, Species at Risk Biologist – Gwich'in Renewable Resources Board (GRRB) This agenda item was discussed earlier in the meeting (after staff reports on February 15, 2021).

The background information is in the binder. The presentation is about adding the Northern Mountain Caribou as a species of special concern under the *NWT Species at Risk Act*. If approved by the management authorities (including the GRRB) to be listed, then a management plan needs to be developed. This must be done within two years.

The background information is in the binder. Suzanne summarized the intent of the report that will be published this year. The report is published every 5 years and was first published in year 2000. They will publish it with all the Boards involved and with the Federal Government. GRRB will receive a request to review the report and to give permission to put their logo on the report.

8. WSF Proposals

8a. "Tsee (Beaver) Project: Dynamics and drivers of beaver population change" Jackfish Creek - Mackenzie Delta

Dr. Helen Wheeler, Anglia Ruskin University, Chelmsford, Essex UK.

The background information of the proposal is in the binder. There are four project objectives **1**. Monitor population in the Jackfish Creek area (East Channel of the Mackenzie River), **2**. Assess long-

term changes and compare to the 1960's survey, as soon as labs open in the UK, they will **3**. Test novel methods; shrub rings (dendrochronology and **4**. Create models of population change in sites, identify permanent & part-time activity.

During the question period, there was interest in understanding more about the trapping of beavers in the 1960's survey to see if there are any correlations to changes in the population. Helen responded that a lot of the expansion in beavers has been linked to climate change. She acknowledged there is a history linked to trapping but that correlation is unanswered at this time, and they hope to find information on this in the archives. She was encouraged to continue to use local indigenous knowledge.

8b. Arctic Boarderlands community ecological monitoring

Heather Ashthorn, Administrative Coordinator - Arctic Boarderlands Ecological Knowledge Society (ABEKS) - Whitehorse, YT

The background information of the proposal is in the binder. The three ABEKS proposal objectives are:

1. To document observations of ecological change made by Gwich'in and Inuvialuit experts for use by communities, groups that seek to understand changes being experienced in the region, cumulative effects and how they effect traditional activities.

2. To monitor, record, and share knowledge and stories about the ecological processes and wildlife status in the north.

3. To support and enable the inclusion of local knowledge in decision making. They are seeking support for objectives 2 & 3 from the WSF, with the budget provided in the binder.

8c. Muskox ecology west of the Mackenzie Delta – Population Survey

Mike Suitor, North Slope and Migratory Biologist – Government of Yukon

The background information of the proposal is in the binder. The proposal objectives are: **1**. To document Muskox abundance on the Yukon North Slope and Richardson Mountains and to identify methods for long-term monitory including community-based focus. **2**. To document Muskox population demography and identify methods for long-term monitoring including community-based approaches. **3**. To continue documentation of Muskox movement and habitat use relative to Porcupine Caribou.

8d. "Arctic Salmon: Samples & Coordination"

Karen Dunmall, Aquatic Biologist – Department of Fisheries and Oceans Canada – Winnipeg, MB *This presentation was provided after agenda item #8e.*

The background information of the proposal in the binder. Karen provides her verbal report on the Arctic Salmon: Samples & Coordination. Thanks to the Harvesters and GRRB for supporting the Arctic Salmon project.

During the question period, Karen clarified possible reasons for the drop in salmon numbers last year. In 2019, there were many salmon showing up (2400 total traded in). In 2020, there were only 20 traded into the salmon project. It goes up and down every year. They are looking at why so many salmon show up as opposed to other years. It could be sea surface, ice cover in the Chukchi sea. It could be less ice and salmon show up in greater numbers. Salmon following food source or productivity in the area. Look at different scenarios and the numbers of salmon that could show up.

8e. Post Calving survey for Barren-ground caribou

Tracy Davison, Regional Biologist – Environment and Natural Resources

This presentation was provided after agenda item #8f (which was also moved up on the agenda).

The background information of the proposal in the binder. Project objectives are to obtain a population estimate for the Tuktoyaktuk Peninsula, Cape Bathurst and Bluenose-West herds. To obtain a fall composition ration for both herds, and to monitor the collars and investigate stationaries when possible.

8f. "Divii, Dall's Sheep Monitoring

Édouard Bélanger, Wildlife Biologist – Gwich'in Renewable Resources Board (GRRB) This presentation was provided after agenda item #8c.

The background information of the proposal is in the binder. The goals are: **1**. Monitor population size, recruitment, sex ratio, group composition, and trends using remote cameras. **2**. To train community members and youth to build capacity and increase opportunity for community members and youth to participate in research and monitoring. **3**. Gather Traditional Knowledge on "Divii (Dall's Sheep) is undertaken by GTC and DCH. **4**. Completions of a master's thesis to test their method. The result of this project will assist GRRB, GRRC's, ENR, Yukon Government, and other planned partner to monitor the population with the direct participation of community members and youth in the data collection and management. This project is therefore important in the management of "Divii (Dall's Sheep) population as set out in the Draft Management Plan by the actions approved for management by the GRRB and by interests by communities.

Gwichya RRC expressed concerns with the Aurora Research Licensing process for research. The RRC has concerns with the amount of information being requested for input monthly. In addition, there are concerns with how the RRC comments are considered.

10a. Rat River Working Group (RRWG) Recommendations - Direction

Sarah Lord, Fisheries and Forestry Biologist – Gwich'in Renewable Resources Board (GRRB) This presentation was provided on Day 2 after agenda item 11a.

The background information is available in the binder. Sarah presents information that indicates a population decline. Similar declines are happening in other Beaufort Sea char stocks (both Dolly Varden and Arctic Char). Mortality in the marine environment and something happening in freshwater could be causing declining population.

Sarah and the Board acknowledges Selwyn Kay's dedication to 25 years of the Char Monitoring. His dedication, diligent record-keeping serves as a wonderful example for Gwich'in youth who aspire to pursue opportunities in fisheries. Mashi Cho, Selwyn. You will be missed.

GRRB has an invitation to provide comments and meet with the standing committee on the review of the *NWT Wildlife Act* and *NWT Species at Risk Act*. The standing committee is a process coming from the Legislative Assembly. Comments would be focused on the actual text in the legislation. There are two topics listed as priorities: (1) Unsettled Land Claim Areas and (2) Guardianship Program. Amy and GRRB technical staff have no concerns to flag as both pieces of legislation are still in the early stages of enactment. Jozef Carnogursky elaborated on there sometimes being comments raised to the GRRB on where people can hunt porcupine caribou but that is more of a GTC and PCMB issue.

It is important to work through the language and a challenging process. We are doing our best to meet the needs of the communities and it takes a while to navigate through legal language.
